



## Terms and Conditions for Custom / Painted Furniture

1. A signed contract is required at the start of all commissioned pieces. **Salvage Boyz** is being commissioned to:

All furniture must be picked up with the remaining balance due within one week of completion. If the remaining balance are not paid and commissioned piece(s) is/are not picked up within 30 days, customer forfeits any paid deposit and Salvage Boyz retains the rights to sell, donate or dispose of the commissioned piece(s).

4. Local delivery can be arranged for an additional fee based on the distance traveled. (Hampton Residents can arrange free delivery) Delivery Fees are as follows:

5. Repairs, humidity and extreme temperatures can delay the finish time. We will notify you immediately if your commissioned piece(s) will not be completed in the estimated time.

6. All hand-painted or stained pieces will have unique, artistic characteristics, that may include brush strokes and/or variation in color.

7. All sales are final. Custom pieces are nonrefundable. However, your satisfaction is a top priority and we will work with you to find a solution. *(Not responsible for buyer's remorse!)*

8. If damage is discovered or additional work is needed after the work has started, we will contact you immediately and let you know if we expect the charges to be higher than agreed on amount. Also if there are any issues with the item(s) once in place at your home contact us within 48 hours. All painted furniture can take up to 30 calendar days to fully cure. During the cure process, your piece(s) should be handled with extreme care.
